Formation

成立

1. The Committee was formed pursuant to the board resolution of Shun Ho Property Investments Limited (“the Company”) passed on 28 March 2012.

Composition and Quorum

2. The Committee shall be appointed by the board of directors of the Company amongst the non-executive directors and executive directors of the Company. A majority of the Committee members should be independent non-executive directors. [3.27A]

Members : The Committee shall consist of not less than 3 members.

Quorum : 2

3. The Chairman of the Committee shall be appointed by the board and should be the chairman of the board or an independent non-executive director. [3.27A]

4. The Board shall appoint at least one director of a different gender to the nomination committee. [B.3.5]

5. The meetings and proceedings are governed by the provisions contained in the articles of association of the Company for regulating meetings and proceedings of Directors.

Authority

6. The Committee is authorised by the board to investigate any activity within its terms of reference. It is authorised to seek any information it requires from any employee and all employees are directed to co-operate with any request made by the Committee. 董事會授權委員會按照其職權範圍進行任何調查。委員會有權向任何僱員索取任何所需資料，而所有僱員亦獲指示與委員會合作，滿足其任何要求。
7. The Committee is authorised by the board to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it considers this necessary. [B.3.3]

Duties

8. The duties of the Committee shall be:

 - (a) To review the structure, size and composition (including the skills, knowledge and experience) of the board at least annually, assist the board in maintaining a board skills matrix and make recommendations on any proposed changes to the board to complement the Company's corporate strategy on such remuneration. [B.3.1(a)]
至少每年檢討董事會的架構、人數及組成（包括技能、知識及經驗方面），協助董事會編制董事會技能表，並就任何為配合本公司的公司策略而擬對董事會作出的變動提出建議。
 - (b) To identify individuals suitably qualified to become board members and make recommendations to the board on the selection of individuals nominated for directorships. [B.3.1(b)]
物色具備合適資格可擔任董事的人士，並建議提名有關人士出任董事或就此向董事會提供意見。
 - (c) To assess the independence of independent non-executive directors. [B.3.1(c)]
評核獨立非執行董事的獨立性。
 - (d) To make recommendations to the board on the appointment or re-appointment of directors and succession planning for directors, in particular the chairman and the chief executive. [B.3.1(d)]
